# Volunteer Income Tax Assistance (VITA) Quality Reviewer United Way of Kenosha County

**Position Type:** Part Time/Seasonal (Grant Funded – Estimated 120 hours)

**Reports to:** Program Coordinator

Location: On-site/in-person at VITA locations

#### **Position Overview:**

The VITA Quality Reviewer is responsible for conducting on-site quality reviews and ensuring accurate and compliant tax return preparation across all VITA sites in Kenosha County. This position provides tax-related technical support, e-filing administration (as necessary), and assistance to volunteers in maintaining program integrity and compliance with IRS standards.

### **Key Responsibilities:**

- Conduct quality reviews of tax returns from all VITA sites.
- Verify all items listed in the Quality Review Checklist (Publication 4012).
- Review supporting documentation and taxpayer information to ensure accuracy of return entries.
- Reference and apply tax law to confirm accuracy of determinations.
- Provide support for volunteers as they complete tax returns.
- Perform final return review with clients.
- Ensure compliance with Quality Site Requirements (QSR).
- Support the Program Coordinator and Site Coordinator in managing returns.
- Adhere to all required IRS publications and guidelines.
- Understand all aspects of VITA site operations and volunteer roles.
- Support program staff and volunteers in maintaining a high standard of accuracy and taxpayer service.
- Perform other duties that advance the goals of the VITA program and United Way of Kenosha County.

#### **Minimum Qualifications:**

- Knowledge of federal and state tax law.
- Demonstrated interpersonal and communication skills.
- Ability to provide clear support to volunteers.
- Strong attention to detail, critical thinking, and problem-solving skills.
- Experience in tax preparation software and e-filing systems.
- Demonstrated ability to manage multiple tasks and deadlines.
- Friendly, flexible, and reliable.

### **Desired Qualifications:**

- Strong knowledge of federal and state tax law relevant to VITA program guidelines.
- Proficiency in tax preparation software and e-filing system,

#### **Requirements:**

- Successful completion of IRS Advanced Tax Law Certification and Quality Reviewer Training.
- Must possess valid driver's license and have access to reliable transportation.
- Must be willing to travel to VITA sites, meetings, and trainings within Kenosha County and surrounding areas.

## **Physical Demands:**

• While performing the duties of this job, the employee is occasionally required to stand, walk; sit; use hands to handle or feel objects, tools or controls; reach with hands and arms; balance; stoop, kneel, crouch or crawl. The employee must occasionally lift or move up to 30 pounds.

## **Compensation and Employment Details:**

This is a temporary, part-time, grant-funded position expected to run approximately 14 weeks from January 6 through April 11, 2025. Benefits are not included.

- Training Period: 4 weeks total
  - o 3 weeks of certification training (3 hours per week) paid at \$13/hour
  - o 1 week of on-the-job training (9 hours total) paid at \$13/hour
- **Probationary Period:** Following successful completion of on-the-job training, pay increases to \$15/hour for a 2-week probationary period.
- **Regular Employment:** Upon successful completion of the probationary period, pay increases to \$17/hour for the remaining weeks, averaging 12 hours per week.
